I. Introduction

This document describes the policies, procedures and record of endowed scholarships managed by the Society of Women Engineers Board of Trustees (SWE BOT) in the SWE Endowment Fund, Incorporated (SWE-EFI)

The predecessor and original SWE Scholarship Fund were established in 1956.

This record was originally created from a review of the SWE BOT files and records in 2000 and will be updated annually in the first quarter of a fiscal year to incorporate new scholarships, changes to existing scholarships and the past fiscal year summary data.

Scholarship descriptions include the Year Endowed, History, Criteria, Initial Endowment Amount and Initial Stipend Date and Amount. Annual Award amounts are found in the documents released annually as a list of "SWE-EFI Scholarships, 20xx-20yy Stipends." Scholarships that are locally selected are listed separately and do not have criteria listed.

BOT internal and interface procedures regarding establishment and administration of endowed scholarships are described in this document.

The SWE document "SWE Scholarship Selection and Award Procedure" focuses on the processes used by the Scholarship Committee and Headquarters to select annual recipients and distribute funds to them.

II. Procedures

A. Scholarship Endowment and Stipends

Endowment:

The Board of Trustees (the BOT) currently requires an endowment of \$25,000 to establish a \$1000 initial scholarship. the BOT makes the final decision on all stipends with input from the SWE Scholarship Coordinator and the donor (if applicable) regarding the scholarship type and size.

The "Society of Women Engineers National Scholarships Program Sponsor Information" and the "SWE Endowed Scholarship Criteria Form" can be found in Attachment C of this document. The Scholarship Criteria Form is used by the endowing donor to establish the scholarship name and the basic criteria for the specific scholarship they are endowing. At times, the endowing donor, whether an individual, family, trust, corporation or SWE section or region, may provide an accompanying letter specifying the Endowment or Scholarship name or other pertinent information. This letter is to be kept with the Scholarship Criteria Form in perpetuity. The SWE Scholarship Coordinator along with the SWE Secretary, the SWE BOT Scholarship Liaison and the SWE HQ Scholarship Liaison must agree to the feasibility of applying the criteria during the selection process. Examples of criteria that do not pose undue restrictions on the recipient selection include: sophomore engineering student, U.S. citizen, specific engineering curriculum such as mechanical engineering. Once agreed upon, neither SWE nor the BOT should change the criteria without donor agreement, if feasible.

SWE-EFI is an Endowment Fund, and as such we do not maintain separate investment accounts for each named endowed scholarship. We do, however, track the original endowment value and any added donations. The funds are pooled for investment. Each separate scholarship endowment is documented

and most are held as a permanently restricted asset. These values are documented in the "SWE Scholarship Fund – Allocated Values" spreadsheet managed jointly by the BOT Treasurer and BOT Scholarship Liaison. Upon specific request by the endowing entity (individual, section or region), the BOT can provide the current value of the principal (corpus) of an endowed scholarship.

The BOT will not accept scholarship donations for a named scholarship unless the scholarship already exists or the full endowment payment is made. For individuals only, a pledge can be made to provide the \$25,000 initial endowment over a three to five year period by using the "SWE Endowed Scholarship Pledge Form" (Attachment D).

The process for funding an endowment is for the donor to submit funds or readily marketable securities to the BOT Treasurer along with a completed Criteria Form. The BOT Treasurer will deposit the funds, acknowledge receipt of funds with the donor, and forward the Criteria Form to the BOT Scholarship Liaison. The BOT Scholarship Liaison will coordinate with the BOT, SWE Scholarship Coordinator and HQ staff to clarify and approve the criteria. Within 30 days of receipt of funds, the BOT Scholarship Liaison will issue a thank you letter to the donor acknowledging the amount of the gift, the scholarship name, criteria and the expected initial stipend date. Quarterly, the BOT Scholarship Liaison will send a summary of endowment donations received by SWE-EFI to HQ so that these donors are recognized in the SWE Annual Report and are included in any donor appreciation events, such as the Halo Reception, if applicable.

Stipends:

The SWE BOT establishes the stipend amount and number of endowed scholarships with consideration of donor requests, when applicable.

The BOT has full discretion as to the number, type and amount of scholarships and stipends conferred each year, including increases/decreases, based on donation history and investment performance. The BOT has a long term goal to increase the value of the scholarship stipends. A donor may add to the endowment at any time and in any amount.

The scholarship funding cycle is run on a fiscal year (July1-June 30) basis. Endowed funds that are received prior to the end of a fiscal year are invested for one fiscal year prior to award of the first stipend. (For example, funds received between July 1, 2009 and June 30, 2010 (FY10) would have the initial stipend awarded in Fall 2011(FY12.)

B. Section/Region Endowed Scholarships (SWE-EFI) – Local Selection Process

In 2000, the BOD and BOT agreed to establish a process that enables a SWE Section or Region to endow a scholarship through the SWE Endowment Fund while retaining the ability to set the criteria and handle the selection of "local" recipients.

The BOT establishes and notifies HQ staff of the stipend amounts per the society level process. The BOT forwards the "locally selected" stipend payments to SWE HQ as part of its total scholarship stipend payment. SWE HQ forwards the checks to the schools after they are notified of the recipients name and supporting information by the Section or Region (Reference FY2001 BOD2). If local sections fail to award scholarships for two consecutive years, the BOT will convert to a Society

selection process in order to assure donations are distributed. Attachment B of this document provides the list of SWE-EFI Locally Selected Endowed Scholarships by Section and Region.

C. Scholarship Recipient Selection Process – Society Level Selection

The SWE document covering the scholarship coordinators and staff processes in detail is described in the Procedure "SWE Scholarship Selection and Award Procedure."

The BOT notifies the SWE Scholarship Coodinator and HQ Scholarship Coordinator of the stipend allocation for each individual scholarship annually. Attachment A of this document describes the Society Level Scholarships. The Scholarship Coordinators work to select the recipients and notify to BOT of the names associated with each scholarship. The BOT pays the total amount for stipends to SWE HQ for individual distribution as required by the "SWE Endowment Fund Procedures" document. The SWE Scholarship Coordinator is responsible for the review and selection of recipients of the society level scholarships. They assure recipients meet all the SWE level and scholarship specific criteria.

SWE conducts two separate selection processes, one for freshman applicants and a second for upperclass and graduate students. These are conducted on a different schedule, making "all grade" scholarships difficult to administer. When possible, the BOT will request donors to select between the two types of awards rather than be all-inclusive.

In 2012, the BOT and Scholarship Coordinators approved new, separate definitions for "reentry" and "non-traditional" students as follows. Existing and new scholarships were assessed as to which categories their criteria would align and reclassified accordingly.

Reentry: Reentry scholarships were established to assist women in obtaining credentials necessary to renter the workforce as engineers. These scholarships apply to:

- -full or part time students
- -any year of engineering school, including graduate school
- -students that have been out of school for a minimum of two years prior to the beginning of the current course of study
- -students that have been out of the engineering or technology workforce for a minimum of two years prior to the beginning of the current course of study

Non-Traditional: Non-traditional scholarships were established to assist women to return to school to obtain an engineering degree. These scholarships apply to:

Full or part time students

- -any year of engineering school, including gradutate school
- -students that have been out of school for a minimum of two years prior to the beginning of the current course of study

In 2018, the Board of Directors made 2 changes to scholarship eligibility. First, they defined eligible gender as "female or identifying as female." Second, they included ABET accredited community colleges as eligible institutions.

SWE HQ provides the following to the BOT Scholarship Liaison annually:

- -Names of the recipients for the locally selected scholarships.
- -Names of any scholarships which were not awarded in a given year, so BOT knows what was not spent.

A typical annual schedule is as follows:

January/February:

- -BOT reviews and approves stipends for award in the fall. (SWE-EFI Endowed Scholarships 20xx-20yy Stipends List transmitted)
- -BOT provides stipend list by Scholarship to HQ for the following year's program
- -Upperclass Scholarship Applications Due (Feb 15),
- Judges Identified and Trained

March/April:

_- Judging of Upperclass Scholarships (Final list April 30)

May:

- Freshman Scholarship Applications Due (May 15)
- -Judges Identified and Trained
- -Upperclass Scholarship Recipients Notified (May 4)

June:

- Judging of Freshman Scholarships (Final list June 19)

July:

- Freshman Scholarship recipients notified (July 18)

September:

Checks mailed to recipients (Sept 15)

December – February:

HQ provides list of Scholarship recipients to BOT

BOT reviews list and releases funds, as appropriate

D. Scholarship Approval and Donor Thank You Process

The BOT typically receives the scholarship criteria from the donor. The BOT Scholarship Liaison collaborates with the BOT, SWE HQ Scholarship Coordinator and SWE Scholarship Coordinator to assess the criteria regarding the ability of SWE to find suitable recipients. If the scholarship criteria requested by the donor seems too restrictive to find suitable candidates, the BOT Scholarship Liaison contacts the donor to recommend more appropriate criteria. Any special considerations regarding scholarship criteria must be approved by the BOT, SWE Secretary, SWE Scholarship Coordinator and SWE HQ Scholarship Coordinator.

Once the criteria are agreed upon by SWE and the donor, the BOT Scholarship Liaison sends a thank you letter to the donor reiterating the amount, criteria and initial stipend award date. A sample thank you letter is found in Attachment E.

E. Reporting

The SWE-EFI funds are audited annually by an auditor selected by SWE. The BOT reports on the status of the Scholarship Account as a whole to SWE Board of Directors and SWE Membership on an annual basis.

Attachment A: SWE-EFI Society-level selected endowed scholarships

The following is the list of endowed scholarships managed by the SWE Board of Trustees. Notes of interest:

- There are ten scholarships on this list that specified as renewable (Abernethy, Barrow, Berry, Central New Mexico Pioneers, Central New Mexico Re-entry, Gilbreth, Gleiter, IBM, Parker and Pressman).
- All funds are designated as "Permanently Restricted" except Gilbreth, Gunther, Pickup, Pressman and the General Fund. Because permanent restrictions can only be made by the donor, and these donors did not make such restrictions, these funds are classified differently for accounting purposes.
- Unless otherwise specified, a scholarship recipient can apply for the same scholarship
 the next year when the scholarship is not specified renewable but is multi-graded.
 That student should be allowed to compete the same as any other applicant in the
 scholarship pool.

Lonnie Lee and Maria Elena Abernethy Endowment for Native Americans in Engineering

- Endowed: 2012, First Awarded in 2013
- Criteria:
 - For freshman, sophomore, junior, senior or graduate Student studying engineering at an ABET accredited university
 - U.S. citizenship required
 - o SWE student membership in good standing desired
 - Native American self-identified required
 - Students must be attending University of New Mexico (Albuquerque, New Mexico) or New Mexico State University (Las Cruces, New Mexico)
 - The student's permanent address is in New Mexico
 - o If there is just one qualified candidate in a given year, SWE may choose to award \$4000 to one recipient if they are an outstanding student with a GPA of 3.5+. If they are a regular candidate, meeting the 3.0 GPA criteria but not 3.5, then we will give them \$2000 and hold the remaining \$2000 award in the following year to another eligible candidate.
- Renewable: Yes. Scholarships are renewable until graduation
- Initial endowment: \$100,000 donated by Dr. Lonnie Lee Abernethy in 2012
- Initial stipend (2013-2014): \$2000 each for 2 scholarships

Alice May Anderson Memorial Scholarship

- Endowed: 2018
- History: Established by family in honor of Alice May Anderson
- Criteria:
 - o For sophomore, junior or senior or reentry engineering students
 - US Citizenship required
 - Financial need preferred
 - Attending California colleges/universities

Renewable: Yes, up to 3 years

- Initial Endowment: \$27,500
- Initial Stipend (2018-2019): TBD

Betty Lou Bailey SWE Scholarship (Formerly Betty Lou Bailey Region F Scholarship)

- Endowed: June 2009
- Criteria:
 - o For sophomore, junior, senior, or graduate student
 - o Attending school or living in the former Region F boundaries
 - o U.S. citizenship required
 - SWE membership required
 - Financial need required
- Renewable: No
- Initial endowment: \$ 25,000
- 2018:Region F added \$895 and changed name
- Initial stipend (2010-2011): \$1000 for 1 scholarship

Anne Maureen Whitney Barrow Memorial Scholarship

- Endowed: 1991
- Criteria:
 - For undergraduate students embarking on or embarked on a course of study compatible with the goals of SWE
 - The scholarship does not need to begin in the freshman year
- Renewable: Yes. Renewable for up to 5 years for a total of 6 years of scholarship.
- Initial endowment: \$100,000 from Anne's husband
- Initial stipend (1991-1992): \$1261.57 (partial year investment) (1992-93) \$5461.91 (first full year)

Mary Jones Berry Scholarship

- Endowed: 2013
- History: Endowed by Mary Jones Berry
- Criteria:
 - For graduate student in any engineering major
 - Selected schools (Virginia Tech, University of Virginia, Penn State, Georgia Tech, Purdue)
- Renewable: Yes, 2 years
- Initial endowment: \$25,000
- Initial stipend (2014-2015): \$1000 for 1 scholarship

Lois Aileen Bey Memorial Scholarship

- Endowed: 2018
- History: Established to honor fromer SWE President Lois Bey
- Criteria:
 - For freshman inchemical engineering
 - US Citizenship required
 - Financial need preferred

 - Student must have leadership potential, Minimum GPA 3.5/4.0
- Renewable: No
- Initial endowment: \$25,000 in 2002
- Initial stipend (2002-2003) \$1000 for one scholarship

Ford Motor Company – 2

- Endowed: 2004
- History: This scholarship was endowed in 2004 from the Ford Motor Company
- Criteria:
 - For junior engineering students in either Mechanical, Electrical or Automotive Engineering.
 - Student must have leadership potential, Minimum GPA 3.5/4.0
- Renewable: No
- Initial endowment: \$25,000 in 2004 from Ford
- Initial stipend (2004-2005) \$1000 for one scholarship

Ford Motor Company - 3

- Endowed: 2005
- History: This scholarship was endowed in 2005 from the Ford Motor Company
- Criteria:
 - For junior engineering students in either Mechanical, Electrical or Automotive Engineering.
 - Student must have leadership potential, Minimum GPA 3.5/4.0
- Renewable: No
- Initial endowment: \$25,000 in 2005
- Initial stipend (2005-2006) \$1000 for one scholarship

Alma Kuppinger Forman PE Scholarship (Formerly Region E Scholarship)

- Endowed: 2014
- Criteria:
 - o For sophomore, junior, senior or graduate student in any engineering major
 - SWE membership required
 - Attending selected schools in former Region E
- Renewable: No
- Initial endowment: \$25,920
- 2018: Added \$34,502 and renamed
- Initial stipend (2014-2015): \$1000 for 1 scholarship
- Additional funding in 2018 for a second scholarship

Lillian Moeller Gilbreth Scholarship

- Endowed: 1958
- History: SWE's first scholarship and meant to be its most prestigious.
- Criteria:
 - For junior or senior engineering students of outstanding potential
 - o BOT should address financial need criteria per early write-up
- Renewable: Yes. Scholarship is renewable for a junior continuing into senior undergraduate engineering studies.
- Initial endowment: Gilbreth was the first SWE scholarship and was funded by member and friend donations and unspecified donations to the Scholarship Fund in memory of Dr. Gilbreth (1878-1972), Honorary SWE member and 'First Lady of Engineering'.
 - Additions to initial endowment: SWE had a campaign to increase the Gilbreth scholarship in 1962 "Support a Scholar, Give a Dollar". This endowment was created by a mix of general donations to the Scholarship Fund. In the 1960's this was the only society level nationally awarded scholarship in the U.S. exclusively for a woman engineering student.
- Initial stipend (1958-1959): \$500 each for 1 scholarship

Roberta Banaszak Gleiter Engineering Endeavor Scholarship

- Endowed: 2011
- History: Endowed by Roberta Banaszak Gleiter, Past-President of SWE

Criteria:

- o Re-entry women in engineering students given priority
- Sophomore or junior student studying Chemical Engineering or Aeronautical Engineering at an ABET accredited university given priority
- o U.S. Citizenship required
- SWE member in good standing
- The scholarship will target "B" students demonstrating leadership and engineering potential.
- o Financial need will be considered, as appropriate.
- o The recipient will be informed of the following:
- The amount of the Roberta Banaszak Gleiter Engineering Endeavor Scholarship is intended to support tuition and fees.
- The recipient is requested to write a letter of acknowledgement to SWE Headquarters, which will forward a copy to Ms. Gleiter.
- Renewable: Yes
- Initial endowment: \$25,000
- Initial stipend (2013-2014): \$1000 for 1 scholarship

Golden West Region Legacy Schoarship

- Endowed: 2018
- History: Endowed with funds from former Region A
- Criteria:
 - For sophomore, junior or senior, reentry or non traditional students in engineering
 - SWE membership required
 - Attending colleges/universities within the former Region A boundaries

Renewable: No

- Initial Endowment: \$29,011
- Initial Stipend (2018-2019): TBD

Mary Gunther Memorial Scholarship

- Endowed: 2010
- Criteria:
 - Two for freshmen and two for sophomore, junior and senior students in engineering
 - o Preference for Architectural or Environmental Engineering
- Renewable: No
- Initial endowment: SWE received approximately \$202,000 from Mary Gunther's estate
- Initial stipend (2011-12): \$2000 each for 4 scholarships

B.J. Harrod Scholarship

- Endowed: 1999
- Criteria:
 - For freshmen in engineering
- Renewable: No

- Initial endowment: Member donations to a member-run campaign to fund a freshman scholarship in honor of a former SWE Managing Director. Contributions started in 1995-96 with \$285, which grew to \$27,842 by 1997-98.
- Initial stipend (1998-1999): \$1000 each for 2 scholarships

Admiral Grace Murray Hopper Scholarship

- Endowed: 1992
- History: Endowed following a member run campaign with member and family donations in honor of "Amazing Grace", a true pioneer who made history in the computer field and major technology strides for the US Navy.
- Criteria:
 - For freshman in engineering
 - Preference to computer related engineering and BS degrees in Computer Science
- Renewable: No
- Initial Endowment: \$22,645 and \$15,319 in 1991 and 1992
- Initial stipend (1992-1993): \$1000 for 1 scholarship

Dorothy Lemke Howarth Memorial Scholarships

- Endowed: 1991
- History: Scholarship was initially endowed through donations from Dorothy Lemke Howarth, long time SWE member and Charter member (1956) Detroit Section.
 Donations were received over a number of years to increase the value and the number of scholarships.

- Initial endowment: Unknown
- Initial stipend (1992 -1993): \$1000 each for 2 scholarships

IBM Linda Sanford Women's Technical Advancement Scholarship

- History: Donations raised by IBM Women's Network in honor of Linda Sanford
- Criteria:
 - For students reentering engineering studies in Computing Engineering,
 Computer Science, Engineering Technology or Mathematical Analysis
 - Re-entry/non-traditional students
- Renewable: Yes
- Initial endowment (2016-2017): \$25,000
- Initial Stipend (2015-2016): \$1000 for 1 scholarship

BK Krenzer Memorial Re-entry Scholarship

Endowed: 1995

- History: Donations raised by SWE Members-at-Large in honor of 'BK' SWE's 24th President, 1986-87, and long time supporter of re-entry of women into engineering.
- Criteria:
 - For freshmen, sophomore, junior, senior, graduate students reentering engineering studies
 - Re-entry scholarship
- Renewable: No
- Initial endowment ~\$25,000
- 2018: Region I donated \$7143

Bertha Lamme Memorial Scholarship

- History: Established by money from Region G Designated Fund
- Criteria:
 - For sophomore, junior or senior, and graduate students in engineering Renewable: No
- Initial Endowment: \$33.331.24Initial Stipend (2018-2019): TBD

Katherine F. Lindquist Memorial Scholarship (SWE Smoky Mtn Section)

- Endowed: 2014
- History: Established by the Smoky Mountain Section in memory of Katherine Lindquist
- History: Moved to Society selection in 2017
- Criteria:
 - For freshman in engineering
 - o Must be residing in Knoxville, Oak Ridge, Johnson City and surrounding areas
 - o GPA: 2.5/4.0
- Initial Endowment: \$25,000
- Initial Stipend (2015-2016): \$1000 for one scholarship

MASWE (Men's Auxiliary of SWE) Scholarships

- Endowed: 1971
- History: Established by the Men's Auxiliary of SWE as the Herbert A (Bud) White Scholarship. Bud was a founding member (1967) of MASWE). MASWE disbanded in 1976 when SWE membership was opened to qualified males. It is in honor of the men who supported SWE in the early years through their MASWE work tangible and intangible. The scholarship was renamed the MASWE Scholarship and with funds managed by the Trustees starting in 1983. The scholarship was significantly increased in the 1990's by donations from a family related charitable trust in honor of Winifred D White (Bud's wife and first SWE Executive Secretary).

Endowed Scholarship Selection

The selection criteria are used to identify the pool of candidates for a specific scholarship. Although these criteria are valuable to targeting specific groups, if the criteria become extremely restrictive, then the candidate pool will be very small. If the complete set of criteria does not generate a qualified candidate, SWE reserves the right to loosen the preferences categories.

Scholarship selection method: All scholarships will be selected at the Society level unless they are endowed by a Recognized SWE Section or Region. If the scholarship is being endowed by a Recognized SWE Section or Region, please select either Society Level Selection or Local Selection.

Candidate Attributes

Minimum GPA: No less than 3.5 GPA for freshmen applicants and 3.0 for all other applicants. If a scholarship is designated for re-entry students only, then there is no minimum GPA requirement. If this field is left blank, a GPA minimum of 3.0 will be assumed.

Under-represented groups preferred: If this is selected, the preferred candidate pool will be from applicants who self-identified as being from an under-represented ethnic group in engineering (i.e., African Americans, Hispanic, Native American, Alaskan Native, Hawaiian Native, or Pacific Islander).

SWE collegiate membership required: This option is not valid for freshmen scholarships.

Major subjects: These are limited to engineering, engineering technology, and computer science majors. Multiple majors can be selected.

Specific colleges/universities: If left blank, all schools will be considered. If indicating preferred schools, please submit a minimum of five schools to help ensure sufficient qualified candidates apply. SWE scholarships can only be awarded to students studying in ABET accredited programs. Note that this is a preference, and if no candidates are found at the listed schools, additional candidates will be considered, with sponsor's approval.

Geographic region: Choose if scholarship recipients can be from any geographic location worldwide, or if you have a preference for the recipient's geographic region. For example, this could be a country (e.g., U.S. Only), one or more states, or a SWE region. Note that you can base the selection on a student's home address, school address, or both. If left blank, all students will be considered.
